## AS-CV Mission & Philosophy

The mission of the Autism Society of America is to promote lifelong access and opportunities for persons within the autism spectrum and their families, to be fully included, participating members of their communities through advocacy, public awareness, education and research related to autism.

Recognizing and respecting the diverse range of opinions, needs and desires of this group, ASA embraces an overall philosophy which chooses to empower individuals with autism, their parents or caregivers, to make choices best suited to the needs of the person with autism. At the very core of the parent choice philosophy is the belief that no single program or treatment will benefit all individuals with autism. Furthermore, the recommendation of what is "best" or "most effective" for a person with autism should be determined by those people directly involved - the individual with autism, to the extent possible, and the parents or family members. Providing information and education to help in decision-making are more highly regarded at ASA than is advocating for one particular theory or philosophy.

Facts about autism to share with your community:

- 1 in 110 births; 1% of all children in United States
- Fastest-growing developmental disability
- 4 - 8 times more prevalent in males than females
- Annual cost of autism is \$90 billion/ lifetime cost 3.5 to 5 million
- Cost of treatment over the lifespan can be reduced by 2/3 with early diagnosis and appropriate early intervention
- Medical treatment for autism is not covered by most health insurance policies in Virginia

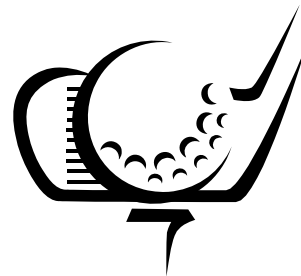

## 2010 Legislative Update

Many bills were introduced during the General Assembly to address the needs of individuals with autism spectrum disorders and their families. Among the bills introduced:

- mandated health insurance for ASD
- tuition assistance grants for students with ASD
- teacher certification and paraprofessional training in ASD
- the creation of an Autism Advisory Council in the legislative branch of state government to promote coordination of services and resources among agencies involved in the delivery of services to Virginians with autism spectrum disorders and to increase public awareness of such services and resources

Despite the concerted efforts of autism advocacy groups across VA, including the ASCV, and families from across the state, the only bill that appears to have passed in both the House and Senate was the following:

*The Department of Behavioral Health and Developmental Services, in coordination with the Department of Rehabilitative Services and other partner agencies, including local community services boards and behavioral health authorities, shall establish specific goals for programs to assist individuals with autism spectrum disorders (ASDs) to obtain and sustain employment. The goals of the program shall include:*

1. *Providing skills training for individuals with ASDs in order to help them obtain employment;*
2. *Providing behavioral supports necessary to ensure success in the workplace;*
3. *Providing training to reduce behaviors that interfere with successful employment;*
4. *Offering education and training on ASDs to employers, in order to increase understanding of these disorders and common behaviors associated with them; and*
5. *Ensuring that individuals with ASDs receive the ongoing behavioral and social support needed to retain successful employment status.*

*By November 1, 2010, the Department of Behavioral Health and Developmental Services shall include in its report to the Joint Legislative Audit and Review Commission a detailed summary outlining the plan for inclusion of specific goals for ASD employment programs.*

## ARC of VA Update on State Budget and Medicaid Waivers

### **Restorations of home and community based services in the 2010-2012 budget include:**

- 250 new ID Waivers for individuals/families on the ID Waiver waiting list (start date of 7/1/10)\*
- Elimination of the proposed cut to respite services. \*
- Elimination of the proposed cut to HCBS Waiver provider reimbursement rates \*
- Elimination of proposed freeze on HCBS Waiver enrollment \*
- Elimination of proposed cuts to Medicaid podiatry and optometry services.\*
- Monthly income for HCBS Waiver eligibility would not be reduced from 300% SSI to 250% SSI \*
- No cuts to consumer directed services

### **Cuts/Policies that remain in the 2010-2012 VA Budget include:**

- \$23 million to rebuild a 75-bed institution at Southeastern Virginia Training Center in Chesapeake. \$24 million to renovate Central Virginia Training Center, an institution in Lynchburg.
- 750 ID Waivers and 134 DD Waivers eliminated (this would make 4 years of no new DD Waivers).
- Assistive Technology (AT) will be reduced from \$5,000 to \$3,000 per year in FY12.\*
- Environmental Modifications (EM) will be reduced from \$5,000 to \$3,000 per year in FY12.\*

**\*Restorations dependent on FMAP funding.** Like many other items in the budget, these restorations are contingent upon a 6 month extension of the enhanced FMAP (a temporary increase in the federal share of Medicaid spending). The U.S. Senate passed the FMAP extension, which was included in the American Workers, State, and Business Relief Act of 2010 (H.R. 4213), by a vote of 62-36. The U.S. House of Representatives has not yet decided on whether to adopt the Senate bill or develop its own bill, which, after passage would be conferenced with the Senate bill.

### **What happens next?**

The budget bill now goes to Governor McDonnell for his review. The Governor has the ability to propose amendments to the budget before the General Assembly's veto session on April 21st.

Robbie Maino, who attends Atlee High School in Hanover County, applied to the Virginia Youth with Disabilities Summit and was selected out of 100+ applications! This 3 day leadership conference takes place in March from the 15-17th at the Hotel Roanoke and Conference Center. Selected youth with disabilities from across the Commonwealth of Virginia that will meet to identify ways to become better advocates and lead more self-determined lives. In addition, Youth Summit participants will have the opportunity to attend Transition Forum workshops specific to their needs and interests. Robbie, was diagnosed at an early age with Asperger's Syndrome, and he has made tremendous strides with his journey. As his parents, we have been so proud of his progress over the past

few years in becoming his own advocate and sharing his insight with others that are on the same Autism journey.

Teachers at Clover Hill High School in Chesterfield County singled out my son Will as the 9th /10th grade STUDENT OF THE YEAR. He was chosen from over 800 students which include roughly 200 who attend a specialty center for exceptional math and science students. This honor is awarded annually to the 9th or 10th grader who "most embodies the traits of responsibility, accountability, respect and honesty." Being his mother, I quite nearly exploded with joy and pride. In 4<sup>th</sup> grade Will had an Asperger's diagnosis, full-time aide, 5-day-a-week tutor, and 1-on-1 math instruction. Now in 10<sup>th</sup> grade he is STUDENT OF THE YEAR and on the A/B honor roll with no aide, no tutor, and no remedial classes. We gratefully owe this to the biomedical interventions of Defeat Autism Now! ([www.autism.com](http://www.autism.com)) which treat underlying or co-existing health problems, typically in the digestive tract, immune system or body chemistry.
