ASA-CV Mission & Philosophy

The mission of the Autism Society of America is to promote lifelong access and opportunities for persons within the autism spectrum and their families, to be fully included, participating members of their communities through advocacy, public awareness, education and research related to autism.

Recognizing and respecting the diverse range of opinions, needs and desires of this group, ASA embraces an overall philosophy which chooses to empower individuals with autism, their parents or caregivers, to make choices best suited to the needs of the person with autism. At the very core of the parent choice philosophy is the belief that no single program or treatment will benefit all individuals with autism. Furthermore, the recommendation of what is "best" or "most effective" for a person with autism should be determined by those people directly involved - the individual with autism, to the extent possible, and the parents or family members. Providing information and education to help in decision-making are more highly regarded at ASA than is advocating for one particular theory or philosophy.

January 15 Rally for Autism Insurance Mandate

As the General Assembly opens its 2009 session, a major Rally is planned in Richmond for over 1000 people on January 15. Rally participants are encouraged to meet with Senators and Delegates prior to and after the rally to urge support for an Autism Insurance Mandate in VA, House Bill 1588.

Please start making plans to "Rally to Richmond" on Jan. 15, 2009, with autism advocates, families and friends from all over Virginia. The game plan is simple: 9 a.m. to 10:30 a.m. visit the office of your delegates and state senators, drop off a card or letter asking them to support HB 1588 and a picture of your child. At 10:30, assemble in Capitol Square by the Bell Tower with other advocates who've joined in the campaign. The Rally begins at 11:00. Wear red and bring a picture of your child or loved one with ASD. Speakers will include bill Patrons, some inspiring parents, and maybe a special guest or two.

HB 1588, sponsored by Delegate Robert Marshall (R-13) and Delegate David Poisson (D-32):

- Requires private health insurance companies to provide coverage for the diagnosis and treatment of autism spectrum disorder
- Coverage will be provided to individuals under the age of 21
- Coverage under this bill is subject to an inflation adjusted maximum benefit of \$36,000 annually
- Coverage of treatments will be provided when prescribed, provided, or ordered for an individual diagnosed with autism by a licensed physician or a licensed psychologist who determines the care to be medically necessary
- The bill includes coverage of the following treatments:
 - Diagnosis
 - Habilitative or rehabilitative care

- The bill applies only to fully-funded health plans governed by state

JANUARY "PDAs" WORKSHOP FOR TEENS AND ADULTS ON THE SPECTRUM AND THEIR FAMILIES

This series of workshops will continue on January 12 with a presentation from Tony Gentry, Ph.D., Assistant Professor in the Department of Occupational Therapy at VCU. Dr. Gentry will introduce us to PDAs, electronic organization tools that can help individuals with autism spectrum disorders who have memory, attention, or organizational deficits manage daily tasks more independently and efficiently. PDAs can improve functional participation at school, work and in the community.
